- 1. A note on Plaintiff's sources and methods of research. A month ago Plaintiff started a Facebook group called, "Discrimination against the Unvaxxed in NYS." Despite shadow-banning and other forms of censorship of the page by Facebook, the group quickly grew to over 400 members. Plaintiff used the group to "crowd source" examples of Discrimination against the Unvaccinated, especially to:
- A. Develop the list on pages 2 & 3 of businesses and venues in Western New York that were discriminating against the Unvaccinated with respect to entry into public indoor places. (Plaintiff was not able to personally verify the list.)
- B. Discover examples of unequal testing protocols between the Vaccinated and the Unvaccinated.
 - C. Learn about examples of medical discrimination by local doctors and hospitals.
- 2. Through this and other means, Plaintiff has also made the acquaintance of many people who have been discriminated against and took the opportunity to interview some of them on the phone. Plaintiff realizes that some of the testimony reported in this Reply is at this point hearsay, however, if the matter comes to trial, Plaintiff can call these victims to testify to what they have experienced.

3. This is partial list of 75 businesses and venues in the Western New York area that were restricting entrance to "Vaccinated Only" prior to the expiration of the Emergency Regulations on Feb. 10, 2022. It is not known how many have kept the policy in effect. There would have no doubt been a lot more on this list, but for interference by Facebook with Plaintiff's page. These businesses and venues are mainly places that young people and people with children would frequent–just the type of clientele that does not need to be vaccinated and is probably more susceptible to coercion so they don't miss out on the "fun!"
